Where we collect your personal information:

The Magic Moments eCards are intended as a service for residents, their relatives and visitors to send and receive eCards. Cards will be checked to make sure that they comply with our content rules below before being shared with the care home team and resident. The content and email address from the sender will be visible to our eCard team administrators. If the card doesn't comply with our eCard Terms & Conditions, the card will not be released to the care home team or resident. Senders will be notified if this happens.

To send a Magic Moments eCard from a resident to a relative or friend, we need the email address of the person to whom you are sending the card. We cannot send a Magic Moments eCard on your behalf without you providing us with this information. Your email address and name provided on the eCard system will not be used for any other purposes. Emails will be retained on the eCard system for a maximum of 1 month.

If you insert an image, including a photograph, into a Magic Moments eCard from a source other than the Magic Moments eCard website, you must have the consent of the person whose image it is and/or the owner of that image to use that image before it is inserted into an eCard and to allow us to store the image for the purpose of sending the card to the recIntellectual Propertyient. In the case of images of children or individuals who are not capable of giving consent, you should ensure that the relevant consent is obtained from the child's <u>or individual's</u> parent or legal guardian. #### **Content rules**

### **User conduct**
